CANCER SERVICES PROVIDES DIRECT SERVICES TO PEOPLE WITH CANCER AND THEIR FAMILIES LIVING IN NORTHEAST INDIANA INCLUDING PRACTICAL HELP WITH TANGIBLE RESOURCES AND EMOTIONAL SUPPORT. PRACTICAL HELP IN 2015 INCLUDED \$155,041 IN FINANCIAL ASSISTANCE TO HELP WITH CANCER-RELATED MEDICAL COSTS, 418 INCIDENCES OF TRANSPORTATION ASSISTANCE, 1,167 ITEMS OF MEDICAL EQUIPMENT LOANED, 1,379 WIGS AND HEAD COVERINGS PROVIDED. 1,152 VISITS WERE MADE BY CLIENTS TO ACCESS PERSONAL HEALTH SUPPLIES SUCH AS BANDAGES.
