## Massage Program Expansion

Cancer Services' Caring Touch Program was an obvious winner from the start. But last year, the oncology massage program was in dire risk of becoming a victim of its own success if leadership failed to make swift and significant improvements.

The program began in 2010 with the help of a generous INSPIRE Grant from the Foellinger Foundation. Cancer Services partnered with Tracy Walton, MS, LMT, who was a nationally renowned expert in oncology massage. Walton traveled to Fort Wayne and provided extensive oncology massage training to a class of 25 local massage therapists. In return for the subsidized training, the therapists committed to provide volunteer hours to Cancer Services' clients.

Since then, Cancer Services has completed two more rounds of professional training and increased the number of volunteer hours available for client care. Cancer Services was providing an average of 50 massages to clients and their primary caregivers each month relying solely on volunteer therapists.

As more clients learned about the Caring Touch Program, and the large body of scientific evidence pointing to the significant benefits of massage, client need quickly outgrew our capacity. The backlog for massage appointments became troubling.

"We were scheduling really far in advance – sometimes two months out, which meant new clients couldn't get in," said Cheryl Dafforn, Program Director of Services who manages the program.

The organization was also forced to institute a policy limiting the number of massages each client could receive.

A plethora of research proves massage is not a mere luxury. It lowers blood pressure, reduces muscle tension and pain and improves sleep. It helps decrease nausea, depression and anxiety for clients and stress for caregivers.

After extensive study and discussion, Cancer Services leaders decided to transition from volunteer to employed massage therapists. They also resolved to find the money needed to renovate the building and create a second massage suite.

In December, Cancer Services hired Lori Schlatter and Rick Ross as massage therapists for the program. Both Lori and Rick had been longtime volunteers with the program before becoming Cancer Services employees.

In February, construction was completed giving Cancer Services two spa-quality massage suites.

These investments have allowed Cancer Services to provide an average of 116 massages per month with a goal of providing more than 120 per month.

The beautiful thing is that nine of our most dedicated volunteer massage therapists have continued to stay on to serve our clients.

"Our massage therapists really love working with our clients," Dafforn said. "So, they have kept up with that commitment to come in and keep volunteering. Fortunately, with Lori and Rick in addition to the volunteers, we are able to keep pace with the clients' needs."

## Dragon Boats are Coming!

Dragon boat racing - rooted in ancient Chinese culture- has become a fun and innovative therapy for breast cancer survivors. Thanks to several Cancer Services of Northeast Indiana supporters, dragon boats also will be the highlight of this year's River Palooza Festival.

The inaugural Fort Wayne Dragon Boat Races will be held on May 30 during the River Palooza Festival on the St. Mary's River in downtown Fort Wayne. Proceeds from the event, sponsored by Parkview Health and 21 Alive, will benefit Cancer Services.

Mayor Tom Henry's Youth Engagement Council in partnership with the Tri-State Watershed Alliance and Glorious Gate Rowing Association are responsible for bringing the dragon boat event to Fort Wayne.



Dragon boat teams include up to 20 paddlers sitting two abreast as well as a steersman steering from the rear of the boat and a drummer who sits at the front motivating the team. The team members work

in unison to propel the dragon boat over the finish line, hopefully with the fastest time.

Dragon boat racing is fun, encourages team spirit and almost anyone regardless of fitness can participate. It's also an ideal activity for breast cancer survivors. The paddling motion and exercise not only improve overall fitness, but also is a great upper body exercise after breast cancer treatment. Several studies show that it can help with lymphedema, a debilitating and chronic side effect of breast cancer treatment.



Julie Fitzgerald, a Cancer Services client, participated in a dragon boat practice last summer and fell in love with it. She has been instrumental in bringing dragon boat racing to Fort Wayne.



"Here I was on chemo, and I found myself in a boat with a paddle in my hand and someone telling me, 'You can do it!' It was a very empowering experience," Fitzgerald said.

The Fort Wayne Dragon Boat Races will have three team classifications: Male, Female and Mixed, with a mixed gender team including a minimum of 8 females. The teams will provide the 20 paddlers and the drummer, but race organizers will provide the steersman.

The teams will range in experience from several years to just a few days in some cases. All the teams participating in the Fort Wayne races will be required to participate in a practice scheduled the week before the Saturday race.

Forming a dragon boat team is easy and is the perfect activity for companies, families, friends or neighborhood groups. It costs a minimum of \$100 per participant to sponsor a boat. A prize will be awarded to the participant who raises the most money.

Fort Wayne's first dragon boat race offers a great opportunity to enjoy the city's rivers while also supporting Cancer Services.
