## Battling Prostate Cancer Together

*Bill & Laine Seidel now help others on the journey*

**B**ill and Laine Seidel have weathered a lot in the 46 years they've been married, but perhaps the greatest storm came in 2004 when Bill was diagnosed with prostate cancer. They stuck together through radiation and treatment; and now, eight years post diagnosis, they are helping others facing the disease. Bill facilitates the Us TOO Prostate Cancer Support group and the Advanced/Recurring Prostate group at Cancer Services, providing men and their caregivers with support and information to help them deal with the disease and the side effects of treatment. Laine provides a lot of support to the caregivers of the men who attend.

"We have to keep them in line," Laine jokes. "On a serious note, you have to face it together because it's scary. I was so scared after Bill's diagnosis, but I found a lot of comfort through research and talking to others. That's why it's important to us to provide that to others."

Bill agrees, "I couldn't have done it without Laine by my side, especially at my appointments. Inevitably, she heard something I missed. We compared notes after each appointment and made sure we gathered all of the information. Now, through Us TOO, we are providing attendees with information

so they can make informed decisions and find peace of mind."

Information is so important on this journey, especially when it comes to treatment options.

"There are so many side effects to the treatment available for prostate cancer," Bills says. "It's important to be informed and know your options. Don't be afraid to ask a lot of questions and seek out additional resources for information."

Bill urges all men over the age of 40 to have a PSA blood test. Though most prostate cancer is slow growing and may never be life threatening, cancer that appears in younger men has an especially high mortality rate, and it's important to catch it and treat it early. Remember, no one ever died of embarrassment, but men have died from prostate cancer.

"Get involved with his health and get him involved," Laine says. "You won't regret doing this together."

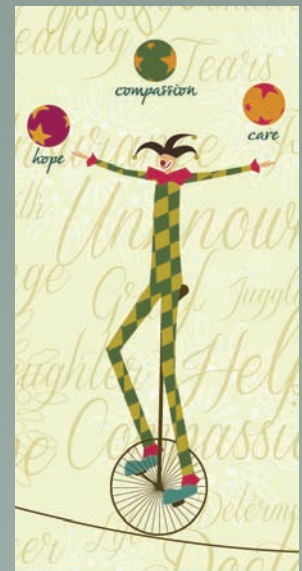

This year is no different. Amazing artwork. Great cause. Join us!

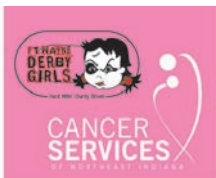

Artificial nutrition and hydration (ANH) can be a contentious issue in hospice, palliative care, and long-term care. This medical treatment has been identified as one of the most common ethical dilemmas to arise in end-of-life care. After all, food and water are basic human needs that symbolize caring and nurturing. The possibility of withholding food and water seems cruel to families and may appear to hasten death. Not only families, but also clinical staff and volunteers, may have ethical concerns over not providing ANH to patients approaching the end of life.

This educational program explores medical, legal, ethical issues, and communication barriers that surround ANH. It will emphasize the need for end-of-life provider organizations to have clear and transparent policies on ANH and to offer training to staff and education for families to minimize family misunderstanding and discord as well as moral distress and anguish of staff.

Application has been made for 2 Contact Hours for a variety of professionals including clergy, social workers, counselors/therapists, psychologists, nurses, nursing home administrators, physicians, case managers, funeral directors, dietitians, occupational therapists, and others.
