Guidance, Support & Peace of Mind

Angie White was three months pregnant when she was diagnosed with inflammatory breast cancer in 2010. A few weeks before her first OB appointment, her nipple inverted. At her appointment, her doctor referred her to the imaging center, and a few days later, she received the news.

"I did a lot of research after my appointment, and all evidence pointed to cancer," Angie said. "But I didn't want to believe it. Hearing the news was shocking. I started crying and ran out of the doctor's office, past my 10-year-old son and 8-year-old daughter who were waiting in the lobby."

Her first thought was that she was going to die, and she didn't know how to face her children. Once she had time to come to terms with her diagnosis a few days later, she sat down with them and told them about her diagnosis. It has been an incredible bonding experience ever since. They've been her supporters through her treatment and always approach things with a positive attitude.

"Our church family has helped immensely, as well," Angie said. "When my kids and I talk about my diagnosis, we approach it from a spiritual place and that has brought us a lot of peace."

Because Angie was pregnant when she was diagnosed, she wasn't able to have radiation, but she did undergo treatment. In late 2010, her cancer had shrunk enough to have a mastectomy, so at seven months pregnant, she had surgery. Her son was born two months later, and six weeks after that, she started radiation therapy.

When she was originally diagnosed, the doctor found a small spot on her liver that was too small to biopsy at the time. In mid-2012, the spot had grown, so they had it tested and it came back as cancer.

"Being diagnosed with cancer the first time was hard. Being diagnosed the second time was even harder," Angie said. "I had convinced myself I was cancer free, but the truth is it was always there. Now I live my life to the fullest, knowing that the cancer may always be there."

The hardest part was telling her family, especially her kids, the cancer was back and treatment would begin again. She's now several months into her second round of treatment and the spot on her liver has shrunk immensely. She and the doctors are hopeful the next time she gets a scan, it will be gone completely.

Through it all, Angie's family and church community have rallied around her. Her sister-in-law and sister have been by her side through her treatment, and her pastor has provided

one-on-one support and spiritual guidance. She's also relied on her Cancer Services' Client Advocate, Maureen, for emotional support.

"She's such a good listener," Angie said. "Cancer Services is a place I can come to vent my frustrations, talk about my fears, and access information I need to ease my mind."

In addition to the emotional support, Cancer Services has provided Angie with wigs and medical supplies. Her family was connected with the Christmas Bureau in 2010, easing the financial burden associated with the holidays and ensuring they had a joyful season during a very tough time.

"I continue to receive supportive phone calls from Maureen," Angie said. "Just knowing she's there gives me peace of mind."

She received her training in epidemiology and nutrition at the University of Michigan, School of Public Health at Ann Arbor.

Since then, she's lost a friend to breast cancer and seen many community members struggle with the disease.

"The programs and services Cancer Services provides are indispensable," Laura says. "Our community is lucky to have such a resource for people with cancer."

In addition to her work as a board member and county outreach committee, Laura also volunteers to drive cancer patients to and from treatment.

"This experience above all others really connects me to the mission of the organization," she says. Having that time in the car to listen to and support our clients is truly something special."
