Life is a Journey, *keep walking*

When Tracy Rau was two years old, she was diagnosed with Retinoblastoma, a rare cancerous tumor of the retina in the eye. To treat it, she had to have an eye and optic nerve removed. One year later, the cancer was discovered in her other eye and she went through the same process. As a result of her surgeries, she is completely blind, but that doesn't deter her from leading a vibrant life. She attended public school and graduated from college. She met a wonderful man and they've been married for twelve years. She volunteers regularly at Cancer Services and mentors others experiencing cancer. Though her life has tested her, she has prevailed and is a stronger woman as a result.

In 2010, thirty years after her initial diagnosis, Tracy started to experience TMJ-like symptoms: neck and tooth pain. She went to the dentist, was referred to a specialist, and had a tooth pulled, on which cancer cells were discovered. She went to the Cleveland Clinic for treatment, leaving her husband behind to work and pay the bills. She underwent treatment for 6 weeks, returning home to see her husband only on weekends.

"When I came home on weekends, I walked through the door and asked him for a strong hug," she says. "He'd wrap his arms around me so tight. I held onto that feeling and oftentimes, it was the only thing that got me to walk out the door to return to Cleveland for treatment."

When Tracy returned to Cleveland for her three-month follow up exam, two small tumors were discovered in her lungs, requiring additional treatment and additional time spent away from home. She finished her last round of treatment on November 2 and returned home two days before her wedding anniversary.

"That meant a lot to me," Tracy says. "I got to be with my husband on our anniversary."

Tracy has had a lot of support along the way. Cancer Services provided much-needed nutritional supplement for her when she was going through treatment and loaned her a wig from the wig salon.

"Denise, my Client Advocate, is a wonderful woman," Tracy says. "She's there to let you laugh and let you cry and always has words of encouragement. It always felt like her arms were around me. That's exactly what I needed."

In addition to Cancer Services, Tracy's husband Bill, mom, and her Seeing Eye dog Porter, rank at the top of her support system.

"They've been by my side every step of the way," Tracy says. "My mom sat beside my bed through all of my treatments;

through every moment of my battle. And Porter, he knows just how to cheer me up. Whenever I am feeling bad, I reach out my hand and he licks it to let me know he is there."

Tracy has been through a lot in her life and all of it has helped her build confidence and strength.

"We don't know why we go through what we do. Life is a journey and I choose to keep walking; to keep pushing myself," she says. "My goal is to strengthen myself, so I can help others."

Gayle Bloom may be retired, but she's definitely not done working! In addition to running an Alpha Mentorship program for gifted and talented students at Homestead High School, she volunteers her time on the steering committees for the IU Colloquium and the Vera Bradley Classic, and serves on the Jorgenson YMCA Board of Directors. She's also been a board member for our organization and has chaired our Annual Tribute Dinner for the past 6 years.

In 2003, Gayle was diagnosed with breast cancer. A teacher at the time, she continued working through her treatment and surgery, taking off as little time as possible. She fought hard and came out strong on the other side of her cancer journey. That's when her long-time friend and Cancer Services' board member Tom Horton reached out to her and asked her to join our board.

"I didn't know a lot about Cancer Services at the time,"

Gayle says. "As is the case with many people I talk to, I didn't think I would qualify for the services. I didn't understand that the organization has something for everyone, not just those who need financial assistance."

Gayle hit the ground running when she joined our board and volunteered to chair the Tribute Dinner that same year, turning it into our most successful fundraiser year after year. Over the years, her passion has grown for the organization.

"Since I didn't know much about CSNI, going through my own cancer, I am now more passionate when I talk about it to other people. It is such a good organization with quality and professional employees, and it really does serve everyone. I have been extremely impressed by its programs and services." Gayle says.

At the end of this year, Gayle's board term expires and she says, "I will miss serving. Cancer Services has become a part of me and a part of my family. I will always be connected and I am excited to see where the organization goes next."
